### **Council Update**

Council and the Administration staff continue to deal with our ongoing situation regarding the Administration Community centre. As this report goes to print we are awaiting a formal proposal from Bob Antone of the Oneida Nation who has agreed to assist in facilitating discussions between Council and the group camped at the Centre. Bob Antone has been involved in this type of work in the past, he has been doing community development work with First Nations for many years, as a trainer, facilitator, mediator, and consensus builder. Bob sits on the Turtle Bench at the Oneida Longhouse. Mr. Antone has been in touch with both sides, has reviewed their issues and finds that the fundamental common issue is one of governance. As such he is recommending an initial review of the Codes. Council has been in support of this approach since taking office in March 2014 and is looking forward to having further discussion in this regard before months end.

In the meantime services continue to be delivered to the community and membership from the old community centre. Administration is tasked with

fulfilling our legal commitments to funding agencies that we deliver services for. One of the key issues at the moment is having access to the Centre to complete the annual audit. There are deadlines to be met for reporting and accountability; failing to provide this information as scheduled is a breach of our agreements and can result in serious implications including a delay in funding and possible service interruptions at a minimum. We continue to work through and meet these challenges as they present themselves.

On June 21<sup>st</sup> we were saddened to hear of the passing of Bob Schell. Bob has lived at the senior's subdivision for many, many years. He was always there to help his neighbours if they needed anything, to watch and make sure they were alright if they were not well. Bob is going to be missed, his cheerful attitude, gentle demeanour, and smile will be hard to replace. Our sympathies go out to his extended family. As usual when the community loses a member, the regular business of Council for the June Council meeting has been postponed.

Council has continued to consider and respond to external requests. Consent has

been given to the Gibson Lake Cottagers Association to use the island south of the narrows for their annual regatta, with the usual terms that it be left cleaned up.

There have been a couple of requests from Six Nations members to be able to spend some time hunting and fishing on the territory. This has been deemed acceptable under the conditions that the persons obtain a permit, must be doing so for personal use only, and are encouraged to be accompanied by a Wahta member. Consideration for spouses of members fishing with their families has also been deemed acceptable.

Regarding the Land Claim, delegates from the Federal and Provincial departments charged with furthering the implementation have been put on hold while a resolution to our ongoing situation at the Administration building is worked out. In the meanwhile a meeting will occur with the lawyer from Aird Berlis on June 25<sup>th</sup> to hear their proposal for moving forward on the claim. Council wants to consider the estimated additional legal fees, validity and probability of the strategies proposed by this firm.

Council was informed that the administration is looking into renewing a bulk price for propane for the community from local suppliers. The intent is that community members and businesses on territory can benefit by a reduced rate based on the total amount of propane sold on territory. When the details are finalized it is expected Council will enter into such an agreement.

On the political side of things Council has had representation at the Iroquois Caucus of Chiefs, the Association of Iroquois and Allied Indians, and the Ontario First

Nations Limited Partnership (Rama Casino distribution of revenues), general assemblies this past month. Upcoming meetings include the Iroquois Caucus and the general meeting of the Assembly of First Nations. We expect when Council is able to hold a general community meeting again we will include representation of these organizations to include the work they do for members knowledge and understanding.

Council and staff will be working through a number of issues arising from new federal and provincial legislation affecting Wahta. This will include a series of community meetings with respect to tobacco sales, matrimonial property, and education. There are many ramifications that come with these new laws put in place by outside governments and its First Nation opinion they are being passed without adequate input or consideration, we now have to deal with the aftermath of those decisions. Please try to attend these community meetings when they occur. Council is also working to improve our communications through other means as well so we can all be informed about ongoing issues that affect us. Remember to check the website regularly for updates in the community.

Council would also like to thank the Women's Drum Group, Ryan DeCaire, Brian and Basil George, Scales and the staff of Wahta Mohawks for their contributions and participation in making Aboriginal Day a special event here at Wahta.

### WAHTA MOHAWKS GENERAL MEETING

The Regular Council meeting has been changed to Saturday July 12, 2014 at the Torrance Community Centre from 10 a.m. to 12 p.m.

The change in location is due to ongoing unrest within the community and the meeting is open to all members of Wahta. Council apologizes for the inconvenience of the few extra kilometres it will take to attend. Please join us in attendance for your input to council

The intent of the meeting is to give members input into the options for Council to pursue regarding ending the ongoing occupation of the Administration grounds. This occupation has been in place since May 5, 2014 and has affected the delivery of services with the potential to jeopardize the ongoing funding flow to the community.

This meeting will be moderated and will not be a place to argue who is right or wrong or discuss the issues of any party. We are looking for positive input and a healthy approach in the best interest of the members of Wahta to move the community forward. The meeting will be consultation style strictly regarding the ongoing occupation of the grounds.

Some options Council has considered and will discuss are:

- 1. Continue with a resolution process with the assistance of a neutral third under status quo conditions;
- 2. Continue with a resolution process with the assistance of a neutral third with the grounds cleared of protesters;
- 3. Use legal and peaceful enforcement to bring the occupation to an end.

### **Prevent Lyme-infected tick bites**

The best way to protect yourself from Lyme disease is to prevent tick bites. Protect yourself if you venture into forested or overgrown areas:

- wear closed-toe shoes, long-sleeved shirts and pants
- pull your socks over your pant legs
- wear light coloured clothes to spot ticks easier
- use insect repellent that contains DEET (common active ingredient to keep biting bugs away) or lcaridin (always read and follow label directions)
- shower or bathe within two hours of being outdoors to wash away loose ticks
- do daily "full body" checks for ticks on yourself, your children and pets

Ticks attach themselves to the skin and removing them within 24-36 hours usually prevents infection.

### How to reduce tick habitats near your home

Keep your lawn and yard well maintained to prevent ticks from living near your home:

- · keep the grass mowed
- remove leaf litter, brush and weeds at the edge of the lawn and around stonewalls and woodpiles
- discourage rodent activity by cleaning up and sealing stonewalls and small openings around the home
- move firewood piles and bird feeders away from the house
- keep your pets, particularly dogs, out of the woods and talk to your vet about tick repellents for your pets
- move children's swing sets and sand boxes away from the woodland edge and place them on a woodchip or mulch foundation
- adopt hard landscape practices (using hard materials like stone and metals instead of soft materials like soil for planting)




### **EDUCATION NEWSLETTER**

Congratulations to all students for the successful completion of the school year. As always we had a heartfelt end of year education banquet hosted this year at the Mohawk Longhouse. The evening began with a welcome to students, parents, and Elders. We acknowledged that this was our 20<sup>th</sup> year celebrating the educational success of our students. Special recognition was given to Lyla Commandant, who at the time was Chief, and supported the idea to recognize the students for their hard work and dedication. A delicious meal of corn soup and Indian Tacos was provided by Lucia Sahanatien and thoroughly enjoyed by all. The students were awarded a certificate of accomplishment and a gift for their hard work over the year. Elected Chief Philip Franks together with Appointed Traditional Chief Terry Sahanatien assisted with the student presentations along with Principal of Glen Orchard School Peggy Barrette. Children who have been attending Longhouse ceremonies were given recognition for their traditional learning as well. We ended the evening with a small social with teachings. It was a night to remember! Such positive feedback was given the next day. It was an enjoyable time; the venue was perfect and it was a great feeling bringing families together with a common purpose.

The post-secondary program is running efficiently at the temporary location. New files have been created, therefore students have been required to resend some of their information. Having said that, I believe the glitches are behind us and we can continue with few barriers. There are some students however, who did not provide contact information on the application form or the number provided is no longer in service. Without being able to access older emails I am unable to retrieve the contact list that was created in April. As for post-secondary we have not received any notice from INAC regarding discontinuation or change of delivery mechanism regarding the program. There is concern that there may be changes in 2014-2015, however at this time we do not know what this may look like.

Our political voices continue to lobby against Bill C-33 which involves a First Nation Education Act. The concerns regarding this Bill have not changed since the first hint of this surfacing. The concerns continue to be in the areas of jurisdiction, increased federal control resulting in lack of local control of culture/language within the education system, and less funding than non-native systems. The First Reading of Bill C-33 was presented to the House of Commons on April 10, 2014.



### **KAGITA MIKAM EMPLOYMENT &**

Intake applications are ongoing for Kagita Mikam Employment & Training Programs. If you are unemployed, underemployed or out of school and would like to receive training to get back into the workforce then support is available upon meeting the criteria and funding availability.

Programs available through Kagita Mikam are: Purchase of Training, Targeted Wage Subsidy, Mobility Assistance, Youth Work Experience, Employment Assistance Supports and Self Employment Assistance. Funding for training is for 1 year only. Members of Wahta Mohawks without status are eligible for funding. A Letter from Wahta Mohawks stating that you have membership must be provided. #### **TIPS FOR JOB HUNTERS**

#### *Use the Internet:*

- There are many different job vacancy websites. Some list vacancies for a variety of jobs, while others have job in specific industries
- Many recruitment agencies use job vacancy websites, but also have job listings on their own websites
- If you are interested in working at a certain business or a particular employer, keep an eye on their website. Most organizations will list vacancies on their own website.

#### Check daily and local newspapers

• Major daily newspapers usually have one issue a week that features most of the job postings. Papers with a weekend edition will generally have a large employment section too.

### Recruitment agencies

- Recruitment agencies often advertise vacancies in newspapers or on their own websites on behalf of employers. You will normally nee to register with an agency before you can apply for the vacancy, but registration should be free, as recruitment companies get paid by employers
- Recruitment agencies will often contact you about other jobs they think will suit you, which can be an effective way to access jobs that are not publicly advertised

### Other places where jobs are advertised

• Career expos-recruitment agencies, universities and industries hold job expos, where employers provide information about job opportunities at their companies, and list vacancies. You can often apply for the positions at the expo, so take a few copies of your resume and be prepared for impromptu interviews.

#### WAHTA MOHAWK TRUST COORDINATOR - PART TIME

The Wahta Mohawk Community Trust was created following the signing of a land claim agreement in 2005 which included financial compensation. The funds were placed in Trust which is governed by a Trust Agreement overseen by five Trustees, three elected by the community and two appointed by the Wahta Mohawk Council. The Trust accepts proposals and funds projects which will benefit the Wahta Mohawk people. The Trust is a separate legal entity from the Wahta Mohawk Council.

Job Description: Coordinator – Part Time - The Wahta Mohawk Trust Coordinator facilitates the work of the Wahta Mohawk Community Trust by implementing administrative measures, assisting in the development and implementation of policies and procedures, advising Trustees, preparing for meetings of the Trust, and overseeing the implementation of decisions by the Trust. On a day to day basis, the Coordinator – Part Time will be the primary point of contact for administrative matters and will report to the Chair of the Trust. The Coordinator – Part Time will work from time to time with the financial staff of the Wahta Mohawks, the Trust Manager, and the Trust Auditor to enable efficient administration of the Trust.

Job Requirements and Qualifications: The Coordinator – Part Time is expected to have good writing skills and basic computer skills in order to maintain minutes of meetings and prepare correspondence. The successful applicant must have the ability to do basic bookkeeping maintain the filing system. The Trust expects professional communications and respect for confidentiality. The successful applicant must be available evenings and weekends. A college degree or equivalent experience is required.

# Important Information for Wahta Mohawk Members



Matrimonial Real Property is changing. Please review some of the frequently asked questions.

The federal Provisions for this act came into effect as of December 16<sup>th</sup> 2014 Our community has on opportunity to develop our own law on this matter, if desired. The community will be deciding our response, either to develop and enact our own law or to follow the Provisional Federal Rules.

#### Introduction

### Q.1) What is the on-reserve matrimonial real property issue?

A1. Matrimonial real property refers mainly to the family home where both spouses or common-law partners live during a marriage or common-law relationship. Generally speaking, provincial and territorial laws protect the matrimonial real property interests and rights of both spouses or common-law partners during a relationship, or in the event of separation, divorce or death. For most Canadians undergoing a breakdown of their marriage or common-law relationship or on the death of a spouse or common-law partner, there is legal protection to ensure that their matrimonial real property is dealt with equitably. Many provincial laws also permit a judge to order a spouse or common-law partner to temporarily leave the family home, particularly in cases of domestic or physical abuse. These provincial and territorial laws do not apply on reserve lands.

Provincial or territorial family laws related to matrimonial personal property, such as money in bank accounts and cars, apply on reserves. However, in 1986 the Supreme Court of Canada ruled that courts cannot apply provincial or territorial family laws on reserves governed by the *Indian Act* if doing so would alter individual interests in matrimonial real property on reserves. As a result, many of the legal protections relating to matrimonial interests or rights that are applicable off reserves are not available to individuals on reserves. Further, the *Indian Act* is silent on this issue.

When the Family Homes on Reserves and Matrimonial Interests or Rights Act comes into force many of the legal protections relating to matrimonial real property applicable off reserves will be available to individuals on reserves, for example:

- A spouse or common law partner will not be able to sell an on-reserve family home without the consent of the other spouse or common law partner and keep all the proceeds of sale;
- One spouse or common law partner will not be able to bar the other spouse or common law partner from their on-reserve family home;
- In cases of domestic violence, a court will be able to order one spouse or common law partner to leave a family home situated on reserve, even on a temporary basis.

### Q.2) Do provincial/territorial matrimonial property laws apply on reserve?

A2. Some rights and protections under provincial/territorial matrimonial property laws apply on reserves and some do not. Provincial/territorial laws can be used to assist couples living on reserve to determine how to divide the overall value of all matrimonial property (house, cash, cars, etc.). Either spouse can ask a court to determine his or her share of the couple's matrimonial property. The court can order one spouse or common-law partner to pay the other a sum of money to make an equal division of the couple's total matrimonial property. However, a court cannot apply provincial laws to force the sale of a home on a reserve or re-allocate rights of possession or occupation of a home. Provincial/ territorial laws cannot change the rights of individual First Nation members to their land.

With the provisional federal rules in force, if a Certificate of Possession has been issued to only one spouse for land where the family home is located, the other spouse may be able to obtain temporary possession of the home, especially if that spouse has custody of the children. This will align with the situation off reserves where courts can decide which spouse or common-law partner gets to stay in the family home, regardless of whose name is on the legal documents.

If the federal rules in the *Act* apply, they will prevent a spouse or common-law partner living on reserve and whose name is on the Certificate of Possession from selling the family home without the consent of the other spouse or common-law partner, whose name does not appear on the Certificate of Possession. This will apply during a marriage or after a separation.

### Q.3) Why is this Act needed?

A3. This *Act* addresses an issue that has been outstanding since 1986 when the Supreme Court of Canada ruled in *Paul v. Paul* and *Derrickson v. Derrickson* that provincial matrimonial real property laws cannot alter rights of possession of reserve land. These rulings identified a legislative gap which meant that on reserve residents would continue to lack basic rights and protections in relation to matrimonial real property since the *Indian Act* was silent on the issue. As a result, relationship breakdown in a First Nation on-reserve community can sometimes lead to homelessness, poverty and separation from cultural and family support if spouses are forced out of their home.

### Q.4) Who does this Act apply to?

A4. The *Act* will apply to married couples and common-law partners living on reserve, where at least one of them is a First Nation member or an Indian.

There is a 12-month transition period from the coming into force of the *Act* for First Nations to enact their own laws before the federal rules apply. After the 12-month period, the provisional federal rules will automatically apply to all First Nations with reserve land, with the following exceptions:

- First Nations that have enacted matrimonial real property laws under this Act during the 12-month period;
- First Nations with a self-government agreement unless they have reserve land and opt into the provisional federal rules;
- First Nations with land codes in place under the First Nations Land Management Act;
- First Nations without land codes in place that are on the schedule to the First Nations Land Management Act will be exempted for a period of three years from the date of Royal Assent.

Once First Nations enact their own matrimonial real property law under the *Act*, the provisional federal rules will no longer apply to their community.

### Q.5) What is the definition of "spouse" in the Act?

A5. The *Act* applies to married couples and common-law partners, where at least one of them is a First Nation member or an Indian. The definition of spouse includes "either of two persons who have entered in good faith into a marriage that is voidable or void." The *Indian Act* definition of "common-law partner" will apply in this *Act*, and means "a person who is cohabiting with the individual in a conjugal relationship, having so cohabited for a period of at least one year."

### Q.6) Why is it important that the Act balance individual and collective rights?

A6. Equality rights are guaranteed under sections 15 and 28 of the *Canadian Charter* of *Rights and Freedoms* (*Charter*), and existing collective Aboriginal rights are recognized under section 35 of the *Constitution Act, 1982*, and referred to in section 25 of the *Charter*. The *Act* is intended to balance individual rights, specifically the need for spouses and common-law partners on reserves to have access to matrimonial real property protections and rights, and the collective interest of First Nations in their reserve lands.

Traditional practices and values vary among First Nations. For this reason, the provisional federal rules in the *Act* provide for First Nation councils to be notified of court proceedings brought forward under the *Act*, with the exception of emergency protection or confidentiality orders. First Nation councils will be able to make representations to the courts about the collective interests of the First Nation members in their reserve lands, the cultural, social and legal context relevant to the application.

#### **Estates**

### Q.7) How do the provisional federal rules in this *Act* affect survivors of estates?

A7. The provisional federal rules in the *Act* provide that:

- A surviving spouse or common-law partner who does not hold an interest or right in or to the family home will have an automatic right to occupy the family home for a minimum of 180 days after the death of their spouse or commonlaw partner.
- The survivor will be entitled to apply for exclusive occupation of the matrimonial home for longer than the 180-day period. Various considerations will be taken into account by the court to determine whether to grant exclusive occupation and the period of such occupation.
- The surviving spouse or common-law partner will be able to make an application to receive half the value of the deceased spouse's or common-law partner's interest or right in the family home and of other matrimonial interests or rights. If the court determines that the surviving spouse or common-law partner is entitled to an amount in respect of that interest or right, the surviving spouse or common-law partner will not be able to benefit from the deceased's will or from the provisions of the *Indian Act* in respect of the same interest or right. In other words, the surviving spouse or common-law partner will have to choose between receiving an amount under this *Act* or an amount or right under the will or the *Indian Act*. Administrators and executors of estates will have access to information regarding the options for survivors that may affect the estate administration.

### **First Nations Matrimonial Real Property Laws**

### Q.8) What if a First Nation never develops its own matrimonial real property law?

A8. It is the choice of each First Nation whether or not to develop and enact its own laws to address matrimonial real property interests or rights on their reserve land. Until a First Nation community develops and enacts its own matrimonial real property law under the *Act* the provisional federal rules, once in force, apply.

### Q.9) What will be the voting requirements for enacting First Nation matrimonial real property laws?

A9. If a First Nation intends to enact matrimonial real property laws under section 7 of the *Act*, the council of the First Nation will have to submit the proposed First Nation laws to the First Nation members for their approval. Every person who is 18 years of age or over and a member of the First Nation, whether or not they are a resident on a reserve of the First Nation, will be eligible to vote in the community approval process.

The council will have to, before proceeding to obtain community approval, take reasonable measures in accordance with the First Nation's practices to locate voters and inform them of their right to vote, the means of exercising that right and the content of the proposed laws. The council will have to publish a notice of the date, time and place of a vote.

The proposed First Nation laws will be considered approved if at least 25 per cent of the eligible voters participated in the vote and a majority of those who participated in the vote voted to approve them.

A First Nation council may, by resolution, increase the percentage of eligible voters required.

### Q.10) What measures exist if a First Nation member is unsatisfied with a First Nation matrimonial real property law?

A10. As a First Nation develops its own laws, the rights of individuals on reserves are protected, as they are off-reserve, by the *Canadian Charter of Rights and Freedoms* (*Charter*) and the *Canadian Human Rights Act*, to the extent that complaints fall within its scope. Should a First Nation not follow the requirements in the *Act* for the community vote, or if an individual community member feels that the content of the law is not *Charter* compliant or otherwise legally valid, the community member will have recourse to the courts.

# Q.11) Why are there no additional minimum standards required of First Nations in the development of First Nation laws to address matrimonial interests or rights?

A11. There are no stronger legal protections available to Canadians than those in the Canadian Charter of Rights and Freedoms (Charter) and the Canadian Human Rights Act, both of which may be enforced through the courts. Both the Charter and the Canadian Human Rights Act, where applicable, will apply to First Nation laws. This approach makes First Nation governments accountable to First Nation members and will respect First Nations' ability to make laws to suit their community needs.
