## 42.04 Adoption of Minutes: March 25th, 2014 - Community Meeting

The Minutes from the March 25<sup>th</sup> Community Meeting were read. A few minor grammatical errors were noted.

Kristal advised that she was only asking for a grievance process as right now Staff does not have anywhere to go if they have a conflict with the Band Administrator. There needs to be a process so that Staff knows where to go when they feel that they are not be heard or do not know where to turn if they feel that the issue is not resolved.

Chief Franks advised that he knows that Staff feel as if there is no recourse when a conflict arises with the Administration process and there should be a grievance process put into place. He also stated that he has had a few complaints about the Administration process. Richard Hay said to follow the HR policy. Kristal advised that it's not working. There was quite a bit of discussion concerning this issue and Chief Franks advised that Council will be looking at employee policies, HR policies etc. and asking for staff input into these polices, making recommendations to these policies and bringing them forward to be voted on and passed.

### 42.05: New Business/Council update:

Councillor Lane indicated that he spoke with Doug Stewart concerning the Solar Project and was inform that Wahta has made it through the first round of examinations with OPA and it is looking good for Wahta. Councillor Lane also indicated that the next step in the approval process will be in June and he advised that the investment return is approximately 9% not 13% as previously stated. Glen Jones asked if it's a 9% return on capital what's the capital and Councillor Lane advised approx. 2.5 million. Glen then asked what the cash flow is for 20 years is it even, stagnated what? Councillor Lane believed that it's a consistent return depending on the sun. There was further discussion concerning the sites and Councillor Lane indicated that both sites (Marsh & Dump) made it through to the second round. He also indicated the both sites will require substantial work.

Chief Franks advised the community that the Woodland Cultural Centre representative is full as Shirley Hay will continue her duties there.
