Chief and Council Update for September Chief Philip Franks

This month we welcomed Senior Administrator Murray Maracle into the organization beginning September 11. Murray comes with management and policy experience and we are looking forward to him applying his expertise as he learns our administrative structure and the many files we have on the go in all areas. In addition, Sue Tait, Cultural Healing Centre Coordinator is also working to develop the new programs dealing with Family Wellness and how it will integrate into our Health, Social and Cultural programming. Please welcome both of them on board, they are keen to learn about our community so they can successfully carry out their tasks.

Through the last of August and into September Council has met regularly on many topics. Councillors Commandant, Schell, and myself attended the Iroquois Caucus. Council has been involved in the hunting issue where Akwesasne hunters who had local permission were charged by the New Brunswick government for harvesting moose. This is an issue that could affect all of our rights on traditional hunting lands. Councillor Commandant will lead the Ontario section of the Caucus Hunting working group and speak with the Mohawk Nation on their views. The Caucus also heard two presentations on Cannabis from member communities, as well as the Ontario government on its project to retail cannabis.

At home, the planned meeting with Minister of Indigenous Relations and Reconciliation took place. The minister and his party were given a tour of our community, learning some of our history along the way, as well as the issues we face looking forward to the future. Discussions centred on how we might develop highway property. The Minister did commit to helping facilitate development once we have a plan in place. Meanwhile the Ministry has funded a feasibility study for the ICG drive and Hwy 400 area through the Aboriginal Economic Development Fund, this will start in the coming months.

We have been having regular Additions to Reserve process meetings on our land claim lands. This is a lengthy process and will take a couple of years at least partly due to items such as land surveys having to be redone, the environmental assessments are now stale dated, permits, easements and many more items that needs to be resolved. The 2014-17 Council determined that attempting to renegotiate the land claim settlement was not a possibility so the work is being carried out to have those lands to be returned to reserve status.

We continue to host community meetings on the issue of what our membership should look like, therefore, what our community wants to be in the future. We are continuing to discuss different ways to be able to reach out to all members. This membership consultation plan will be brought forward soon.

Another basic governance issue is to review our election regulations. A legal opinion on the current one shows there are areas that need to be looked at in more detail, the full review will be available in the next few weeks. It is hoped to have something in place well prior to the next election keeping in mind the consultation process with members, acceptance procedure and filing to INAC. Wahta is what was called a Band Custom Election community having opted into that Indian Affairs designation back in the late 1970s. At that time, off reserve members votes were accepted and the term of office was extended to three years.

Dealing with community capital projects such as housing and water Council will be meeting with our engineering firms for progress reports. Availability of lands, housing, and clean water members continue to be in Council's strategic planning.

On the issue of community safety Council has arranged to meet with the District of Muskoka regarding Muskoka Rd. 38. On the agenda will be the calming of traffic, possible shoulder widening, vegetation management, community safety zone, signage, and general long term planning for the road. Community members are concerned about the number of cars and speeding through our community. The incidence of people going off the road seems to be increasing and these drivers go too fast without knowledge of what is ahead. As part of community safety we will also meet with the Ontario Provincial Police to review and renew our relations with that police force.

Council will be hearing from Dnaagdawenmag Binnoojiiyag Child and Family Services based out of Hiawatha. This will be to gather information so that we can consult with people here about whether we want to opt out of the service being delivered by the local CAS and accept service from this Indigenous run agency. The Dnaagdawenmag Binnoojiiyag should have provincial designation as a full service early next year. Indications are that if we opt in there will be social workers hired and based either in Wahta, or nearby. The approaches from these service workers are based on the fact that Indigenous workers have life experience on First Nations and are specially trained.

At this time there are two by laws being worked on. The first is an improved by law on hunting and fishing. The current one is very archaic having been developed in the 1970s. A wider encompassing one will allow us to consider traditional hunting practices. One issue many First Nations are experiencing is how to allow other Indigenous persons to hunt in the traditional areas and still manage the natural population.

The other bylaw will deal with trespass in general and consider designation of public areas in the community as well. The latest issues community members have faced is having verbal contracts over property and then not being able to reclaim their residences from those who are living there. First, always ensure you have legal contracts in place so this doesn't occur. The bylaw would give some enforcement measure to the issues if mediation does not work. For non members the bylaw would be added strength to our Residency code.

These have been some of the items currently being attended to by Council. Please plan to attend September 30 for the General Meeting. Once again if there are questions or comments you have don't hesitate to contact the Council office or your Council members.

<u>o7.05.01 Northstar Medical Cannabis</u> – Met with Northstar to discuss the possibility of a licensed facility on territory. A partnership was discussed providing a land lease and revenue sharing. Needs further consultation and legal review. Will discuss at next community meeting and general meeting.

o7.05.02 Poverty Reduction Fund – Council has endorsed the project work plan for the Poverty Reduction Fund. This fund will focus on a Women with children support group.

It will provide supports for Mothers and children in areas in need, removing barriers for mothers so they can provide for their children, preparing and building confidence for mothers entering the workforce. Ensuring children are provided with programs and supports for a healthy successful childhood. Nutrition baskets, Financial assistance for children's back to school clothing (winter coats, boot, hat, mitts etc.), financial assistance for holidays (toys, food), life skills work shops, money management, self esteem, cooking, sewing, budgeting.

o7.12.01 CAS Protocol Meeting Jay Herbert/CAS – Reviewed CAS protocol with legal, made changes to better reflect the rights of Indigenous children. Other items or review included the local Police policy, Dnaagdawenmag Binnoojiiyag Child & Family Services option as well as developing our own plan of care with the local customary care homes available when needed. CAS will be reviewing our protocol and notifying us of any concerns, once completed signing will take place.

o7.12.02 Brushing Contract Review – Draw will be held at public meeting July 25, 2017. 10 contracts are available, a total of 31 applicants have entered the draw. As with all past contracts 50% of total amount is awarded for brushing contracts, therefore each contractor will be paid \$1,389.83 per kilometre of line brushed. Each contract will consist of 3 kilometers so the approximate contract will be for \$4,169.50 total for each contractor.

Once the contracts have been awarded a meeting with all the contractors and Hydro One will be organized prior to the commencement of any work. Safety training attendance is mandatory for contractors.

o7.12.03 Iworq Software – Training is now underway for this software to provide and ongoing inventory of Wahta Owned Houses Construction Date, Size, Well Depth, map coordinates etc. It will also include Wahta Assets, Physical Plant Assets (such as HVAC, plumbing), Roads and Roads Assets (such as a particular road, a culvert, a sign). This will allow us to do inventories of assets and know where they are located (it will also involve numbering all rooms in buildings). Access Control (mainly keys) will be tracked with a record of who has what keys, fobs and cards. The final aspect of implementation is Work Management. It will allow us to create Work Orders for things from cleaning bathrooms to plowing snow. The Work Order component will include what machinery we are using and the human resources used for the task.

o7.12.04 Meals on Wheels – A survey was done indicating that the seniors were happy with the meals made from a local restaurant as opposed to made from the band hall. It will be closely monitored to see if they are consistent with what they offer. The cost is within budget.

o7.12.05 Housing Policy – Reviewed the Housing Policy Subsidy Application. This policy is intended for renovations or construction of homes and not for home purchases. The FNMHF (First Nation Market Housing Fund) will provide access to financing a home and larger renovations.

07.12.06 Election Regulations Review Motion – Motion required by Attorney Alisa Lombard, newly employed at Maurice Law. See motion below.

o7.12.07 Language Revitalization – General discussion with Ryan DeCaire on the objectives of the language revitalization project, barriers to language, community history of language and possible steps moving forward.

07.12.06 – Motion to approve the legal review of the Wahta Mohawk election regulations carried out by Attorney Alisa Lombard at a cost of approx. \$5000. Carried by consensus

o7.19.01 Scotiabank – Met with Scotiabank representatives to discuss the Wahta Trust interest payments that come back to Wahta. Currently short term GIC options are not a great deal higher than current interest rates. They proposed a new investment portfolio with ease of liquidity if money is needed for infrastructure or capital projects or trust projects. We will also speak with the TD Bank on this as well.

07.19.02 ATR Hwy Permit – Send highway permit to Falls Law for legal review for Additions to reserve process currently underway.

o7.19.03 FNMHF Market Based Housing Policy Approval - The FNMHF (First Nation Market Housing Fund) Housing Policy is approved in principle. The council resolution requires more specific wording, signing will be deferred.

o7.19.04 Sovereign Wealth Fund – Hydro is selling shares to First Nations to sell off part of hydro. An Ontario wide agreement was presented to Chiefs of Ontario, the sign on cut off date is early 2018. Hydro requires 80% of First Nations to sign on. No money required up front but shares must be paid back and returns are not expected for some years.

o7.19.05 Membership Review Meetings – Inquire if Alisa Lombard is available for meeting with the community on the legal review of the membership code. Start community meetings in September.

o7.19.06 Hunting and Fishing – Iroquois Caucus is requesting financial assistance to help with a hunting and fishing case in Akwesasne currently in the courts. They have formed a harvesting committee to deal with this issue specifically and are requesting a meeting with the Chiefs for further discussion. Further information is needed for decision on financial contribution.

July 2017 Council Public Meeting Minutes

Date: July 25, 2017

Present: Chief Franks, Councillor Schell, Councillor Commandant, Councillor Greasley, Councillor Strength-Fenton and members.

Call to Order: The meeting was called to order at 7:06 pm

Adoption of the Agenda: Moved by Councillor Commandant, Seconded by Councillor Schell. Carried.

Adoption of Minutes of June 27, 2017: Moved by Councillor Strength-Fenton Seconded by Councillor Commandant. Carried.

New Business:

• **Hydro Brushing Draw** – Scott Aubichon Lands Manager conducted a lottery for the Hydro brush cutting along the distribution lines, the total value of the contract is \$91 000. There is 30 km of brush each contract is 3km in length for a total of 10 contracts at \$4200 each. If your name is chosen you are responsible and must be on site at all times, if you have people helping you, the contract will still be in your name and you are responsible for the safety of the workers. The draw was held randomly, all names were called and assigned a number from 1-31. Only the first 10 people will be contacted, if anyone opts out then their slot will go to #11 and so on.

• **iWork Software Database** – This software will initially have details about Wahta owned houses with information such as construction date, size, well depth etc. It will also include coordinates so a house can be mapped.

We will then add Wahta assets, physical plant assets (such as HVAC, plumbing), roads and roads assets and all other band owned equipment.

This will help with budgeting purposes so we will have an idea of what is required from year to year. This could eventually expand to private homes on reserve in terms of budgeting for renovation dollars for things such as septic systems etc. All data is kept in the cloud.

- **Hydro Sovereign Wealth Fund** Hydro is selling shares to First Nations to sell off part of hydro. An Ontario wide agreement was presented to Chiefs of Ontario, the sign on cut off date is early 2018. Hydro requires 80% of First Nations to sign on. It must be looked at in more detail, no money up front but shares must be paid back and returns are not expected for some years. It is not tied to hydro delivery charges on reserve.
- **Meals on Wheels Survey** 8 Survey recipients indicated that the elders were happy with the Hook and Ladder. This will continue to be monitored, if there are complaints it is best to speak with Amy first. Other options are available if needed, Amy will follow up with everyone to check on the consistency and quality.
- Northstar An opportunity to partner with Northstar has been presented to council. They would like to apply for a license and propose a revenue sharing option and land lease deal. Demand is higher than supply, licensing times are quicker now especially for First Nation communities. Step one is to provide a letter of interest and then work on a Memorandum of Understanding. Any deal would be vetted legally with the community consultation process to follow. Tim Thompson stated that the credentials of the company and people involved be looked at.

Olivia Franks asked if it is healthy for the community to have people selling marijuana on reserve, at this point it is farming and pharmaceutical wholesaling, retailing is not yet determined. Shirley Hay commented that any potential deal include a certain percentage of profits go specifically to culture. More information will be forthcoming.

• **Scotiabank Update** – There is currently a balance of \$1.9 million in interest gained through the trust that is turned over to a separate Wahta Mohawks TD account. The trust cannot hold that money and maintain it as tax free. We are looking at ways to get a better return, the level of interest sitting in the account is approx. 2% roughly the same return as a GIC. It must be a cautious and balanced portfolio. Chief and Council will meet with TD representatives on this portfolio.

• **Enaahtig Healing Lodge** – Shirley Hay would like to be a board member for Enaahtig Healing Lodge. There is a vacancy for a Wahta Mohawk member. The letter that outlines the responsibility of a Board member can be put in the newsletter. Chief and Council will support interested candidates.

Old Business/ Follow-up:

- CAS Protocol Meeting Update Chief and Council met with Simcoe Muskoka Family Connections to discuss the protocol. They are currently going through many changes and disbanding the aboriginal unit and encouraging us to join the Dnaagdawenmag Binnoojiiyag Child & Family Services. Service delivery being so far away out of Hiawatha could be an issue, once we meet with them more information will be forthcoming. We had a legal review of the protocol and specific ways to strengthen the protocol were recommended. They are supposed to tell us when they are coming onto territory, which has not always been the case, the new protocol outlines this clearly. One other recommendation was to set up customary care homes, in which homes in the community become qualified to be used instead of taking children off reserve, these homes including kinship care should be adequately compensated.
- **Membership Code Meetings** Meetings will soon commence this fall for citizenship review. The legal review of the Membership code has been completed and released for members review. Election regulations will also be legally reviewed.

July Motion Summary:

07.12.06 – Motion to approve the legal review of the Wahta Mohawk election regulations carried out by Attorney Alisa Lombard at a cost of approx. \$5000. Carried by consensus

Questions/Comments:

Rama – A meeting has been scheduled with Dan Shilling from Rama to discuss land in Port Carling. It as suggested that the land be cleaned up, the grass is very tall and the area is unkept.

Irma White was asking about the Policy development for the Long Term Care project. Chief Franks stated that we are not at that stage yet.

RE: BACK TO SCHOOL 2017-18

Dear Chief and Council, Education Directors, Parents/ Guardians/Caregivers and Learners,



The purpose of this brief communication is to wish everyone the best for continued success as we embark on a new school year. We would also like to take this opportunity to keep everyone apprised of the wide variety of exciting and productive lifelong learning initiatives underway. As you know, the Chiefs of Ontario takes action on the mandates provided by the Chiefs in Assembly and we have many mandates that pertain to the lifelong learning continuum. We will not be able to provide in-depth information on every activity in this short letter; however, we encourage you to visit the Education Portal on the Chiefs of Ontario website at http://education.chiefs-ofontario.org/ to obtain further details.

The United Nations Declaration on the Rights of Indigenous Peoples and the Calls to Action of the Truth and Reconciliation Commission continue to guide the evolution of our relationship with the settler governments in a positive way. First Nations control of First Nations education is a founding principle of the evolving relationship and is a stated and fundamental goal of all activities underway. As First Nations, we are adamant that all education initiatives, inclusive of design, development; implementation and evaluation of all projects, programs, policies and legislation are led by First Nations. Although the present circumstances do not always allow for this type of partnership relationship, we continue to strive to make this the standard way of addressing challenges and barriers.

The following is a brief list of current activity underway. We encourage you to explore them more fully and get involved to ensure we meet the unique and diverse needs of our learners in the most appropriate way to ensure success for our people, communities and nations.

National Joint Collaboration

- Joint Task Team on writing a Memorandum to Cabinet this fall to "unlock" funding to support K-12 education at the community level;
- Joint Task Team on Funding Mechanisms to jointly discuss and elaborate on options for regionally-based fiscal frameworks and funding mechanisms for First Nations K-12 education;
- Joint Task Team on Statutory Funding to discuss and explore options on how to establish a statutory/ legal guarantee of education funding for First Nations;
- Joint Task Team on Early Childhood Education which is sharing technical expertise and knowledge to create a report on ways to improve access to quality early childhood education for First Nations learners;
- Joint Task Team on Northern and Remote communities provides an opportunity for regional experts to discuss and make recommendations on educational concerns that are unique to northern and remote First Nation communities:
- First Nations Review of Federal Post-Secondary Education Programming to determine policy and funding changes to best meet First Nations needs based on inherent and Treaty rights to education.

Charting Our Own Path Forward

- The driving impetus for this initiative is a call by the Chiefs in Assembly for the development of
 recommendations on systems and a funding framework for education. There will be opportunities
 provided this year for grassroots and regional engagement on the development of these
 recommendations.
- Additional engagement areas for the purposes of making recommendations to the Chiefs in Assembly include Post Secondary Education and Early Childhood Education.

Special Education

• The Special Education Support Technicians have planned and are delivering several information sharing and professional development opportunities for First Nations including, a quarterly newsletter, three information sharing/professional development gatherings and several webinars.

First Nations Lifelong Learning Table

- A bilateral process between First Nations and the province that includes grassroots and regional engagement on several priority areas jointly designed to address challenges and barriers associated with the education of First Nation learners in the provincial education system.
- The five overarching priority areas include:
- Relationships
- Language and Culture
- Curriculum
- Information, Access and Accountability
- Policy Development

At the Chiefs of Ontario, we look forward to addressing challenges, issues and barriers on behalf of our learners to ensure they have opportunities to fulfil their educational aspirations. We will undertake all activities with a sense of moving towards full and complete control over lifelong learning while ensuring we work in full partnership with our federal and provincial counterparts as required. Customary Care

Customary care is an important care option for First Nations children who are not able to remain with their immediate family. It is a family-based care model reflective of the culture, values and traditions of the child's parents and community. It recognizes that members of the child's immediate and extended family and community share responsibility in the provision of care to a child, who is or may be in need of protection.

There are two kinds of customary care:

Traditional Customary Care

For First Nations communities, customary care refers to care throughout an individual's lifespan and it is a way of life in which the community takes care of its own members according to its own customs, traditions and standards. Customary care is sanctioned by tribal laws that are indigenous to each Band or First Nations community; tribal laws give Chief and Council the authority to act on behalf of the community in matters related to child and family services. For this reason, the contents of a Customary Care Agreement may vary between each Band or each First Nations community. The mandated child protection agency may or may not be involved in traditional Customary Care Agreements. A traditional Customary Care Agreement may be entered into by a child, the child's parents, the child's Band, or the alternative caregivers who will be providing out-of-home care for the child, pursuant to the Band's customary care declaration.

Formal Customary Care

Where a child protection agency determines that a First Nations child is in need of protection, removal of the child from the parents/caregiver is required and there is a customary care declaration by the Band, the agency may grant a subsidy to the person caring for the child. Formal customary care is recognized as a culturally appropriate placement option for First Nations children, but the child's placement must be supervised by a child protection agency pursuant to the Band declaration and the terms of a signed Customary Care Agreement. This service is provided by the Simcoe Muskoka Family Connexions FNMI protection team and resource team.


