Chief and Council Update

During August council has been engaged in a number of areas, some finalizing current work as well as addressing newer issues. We have covered areas of governance, capital facilities, housing, and community safety. Earlier, Councilors Commandant and Schell had attended the Ontario Chiefs General Assembly which saw the election of new regional chief, Roseanne Archibald. The two councilors are also involved with hunting and fishing issues as representatives to the Iroquois Caucus committee.

Councilor Strength Fenton is a Wahta representative on the Board of Directors to the Woodland Cultural Centre. A recent meeting saw adoption of the 2017-2018 audit, updates on programs and accomplishments of the staff, and a report on the Save the Evidence campaign and renovations. I also attend the Woodland Centre as Chairperson of the board representing member communities Wahta, Tyendinaga, and Six Nations.

Councilor Greasley will soon be attending information session on Indian registration and band membership. The meeting will cover background on most recent developments by INAC in those areas. There will be discussion on the removal of the 1951 cut off date for status, devolving membership responsibility to the First Nations, and inequities to registration and band membership, among other things.

I have joined the Health Social Advisory Board of the Association of Iroquois and Allied Indians in addition to being a part of the Chiefs Council for the association.

Council as a whole highlights of the past month are as follows:

Muskoka Road 38 will become a Community Safety Zone as passed by the District of Muskoka committee meeting I recently attended. Speed fines will be doubled for a 6.5 km stretch beginning on our west boarder and on to just past What A Convenience store. The rest of the roadway does not meet criteria set out by the district at this point in time but can be reconsidered if necessary in the future.

Not so good news for our administration and community centre. A whole roof replacement will have to be performed as well as repair to other water damages at a cost above \$800,000. Council will need approve a plan to approach this unfunded task so work can begin.

The Additions to Reserve process begins again in September as we work to regaining title to those lands taken from us in 1918.

A housing policy was adopted by Council, and the First Nations Housing Market Fund officially kicked off this month. Partnered with the Bank of Montreal, we should be realized better mortgage rates as well as other options to owning a home, whether a new build or purchasing an existing house.

A revisit of the Wahta Development Corporation with our lawyer will soon enable us to once again advertise for Board members to serve as an initial board to get the corporation up and running.

The landfill long term plan will be developed soon as we await submissions for an engineering contract to help steer the path forward. An ultimate goal will be to eventually close the landfill and ship trash out of our lands.

The Wahta trespass bylaw saw a final tweak and will be posted for public comment prior to submission to Indigenous Affairs Canada.

The summer went by too quickly as usual. School buses will be soon be running once again. We want to extend best wishes to all as we move into September. Once again, please contact the office or council for more information on any of the above issues.

Wahta Mohawks Community Meeting Minutes Date: Tuesday July 4, 2018

Present: Chief Philip Franks, Councillor Lawrence Schell, Councillor Blaine Commandant, Councillor Strength-Fenton. Regrets Councillor Teresa Greasley

Call to Order: The meeting was called to order at 7:02 pm.

Adoption of Minutes of May 29, 2018: Moved by Councillor Commandant Seconded by Councillor Schell. Carried.

New Business:

TD Trust Interest Account – Another meeting scheduled to go over an investment policy for the Trust interest account.

Water Treatment Plant Update - Finding the water source is still an issue, the area should be close to the units and not the baseball field as previously discussed. Another meeting is to be held to get further updates and look at more water sources.

Invasive Species Discussion - There is a new invasive species called Phragmites that gets quite high and needs to be sprayed or it can take over swamps, wet and dry lands. Spray is commonly referred to as Round Up with specific restrictions. We need to commit to joining all the other surrounding communities to make this work and stop the spread. The people who do the spraying are trained, there are spraying stipulations on wind conditions etc. Resolution required for Wahta.

- Chiefs of Ontario Conference Update Election held for Regional Chief. Isadore Day was the incumbent, by 3rd round of voting Rosanne Archibald won the election. Rama would like to take full partnership in the limited partnership agreement, this is opposed and currently on hold. Rama already gets other funding from Casino funds. The Province has lifted ban for licensing Long Care Term projects, the licensing phase is extensive. Long term feasibility must be considered. Phase Two Long care study is almost complete.
- Education Update School Bus/Education Assistants A School bus for Wahta children that will take them directly to school has been secured, this will reduce travel time for students. The Renewed Education Enhancement funding is approved and will be helping 4 education assistants for Wahta children in need.

Old Business/ Follow-up:

- **New Relationship Funding** MCR required for one-year renewal which funds the lands Manager position and related activities.
- **Church Roof** Building Inspector suggested new roof with downspouts and eavesdrop for ice and water.

 The current roof was built in 2004. Matthew will obtain quotes. This project could be funded by the Wahta Trust.

June Motion Summary:

Questions/Comments:

- Chief Franks spoke of some complaints made by Muskoka residents/cottagers about the electronic signs. He made the point that no one took notice when they took the ATR lands or ran old highway103 through our lands or when the hydro lines came through our lands. The viewing time on the highway is less than five minutes.
- The Federal Government is looking at a new legal framework legislation which could eliminate the Indian Act. They may offer larger funding possibly in 10-year funding blocks for those nations that are ready depending on linguistic group. There are sill many unanswered questions around how it will roll out. The Framework has been rejected by the AIAI Chiefs.
- Chief Franks was notified that there may be some sort of protest in the evening over various issues such as assimilation, band councils, confederacy systems, hunting. Details are still unclear.
- Councillor Schell stated that Haudenosaunee Longhouses generally do not agree on issues. The position council takes on the Longhouse should be up to the people.
 - Mery Dewasha addressed the change of the Indian Act in 1967. He stated that we own all resources of this land now, this is protected under the Indian Act as well as treaty rights to hunt and fish. The provincial system could eliminate this.
- He advised that if the Indian Act is abolished then the Crown may no longer own the land, it is important to retain title of the lands without Provincial or Federal rule. There are also special rights as aboriginal people to travel to US with a letter from your reserve and a status card, no green card is required.

Next Meeting Date: Postpone one week to Tuesday August 7, 2018

The Story Behind Orange Shirt Day

"I went to the Mission for one year. I had just turned 6 years old. We never had very much money, and there was no welfare, but somehow my granny managed to buy me a new outfit to go to the Mission School Institute. I remember going to Robinson's store and picking out a shiny orange shirt. It had eyelets and lace, and I felt so pretty in that shirt and excited to be going to school! Of course, when I got to the Mission, they stripped me, and took away my clothes, including the orange shirt. I never saw it again, except on other kids. I didn't understand why they wouldn't give it back to me, it was mine! Since then the colour orange has always reminded me of that and how my feelings didn't matter, how no one cared and how I felt like I was worth nothing. I finally get it, that the feeling of worthlessness and insignificance, ingrained in me from my first day at the mission, affected the way I lived my life for many years.... I want my orange shirt back!" Phyllis (Jack) Webstad, Dog Creek, BC

This orange shirt taken from one child, is a symbol of the many losses experienced by thousands of students, and their families and communities, over several generations including: loss of family, language, culture, freedom, parenting, self-esteem and worth and painful experiences of abuse and neglect. Wearing orange shirts are a symbol of defiance against those things that undermine children's self-esteem, and of our commitment to anti-racism and anti-bullying in general.

The date was chosen (September 30) because it is the time of year that children were taken from their homes to residential schools, and because it is an opportunity to set the stage for anti-racism and anti-bullying policies for the coming school year. Orange Shirt Day is also an opportunity for First Nations, local governments, schools and communities to come together in the spirit of reconciliation and hope for generations of children to come.

Wearing an orange shirt and promoting the slogan, Every Child Matters, is an affirmation of our commitment to raise awareness of the residential school experience and to ensure that every child matters as we focus on our hope for a better future in which children are empowered to help each other.

Orillia Courts now have the use of an Eagle Feather

On June 20th, 2018 Rama's Chief, Council, Social Services, Biidaaban, and community were invited to a special Eagle, Feather ceremony at the Orillia Courthouse. The Enaahtig Healing Lodge and Learning Centre Justice Program also brought their Eagle Staff. The event was open to anyone who wanted to come.

Rama Chief Rodney Noganosh provided opening remarks for the event. He saw the ceremony and the use of eagle feath- Terri-Dawn Craig OPP (right) introduces Rama First Nation ers for our people in a courtroom as a step forward in the Chief Rodney Noganosh to speak. Elder Lorraine McRae relationship between our peoples. He also said that First Na-

tions people are overrepresented in the courts and jails. Midewiwin Elder from Beausoleil, Hector Copegog, conducted the ceremony. He taught that the Eagle is

> the closest to the Creator and intervened on all peoples behalf when a prints produced by the Ontario Minismalevolent spirit was going to destroy creation. "Our people hold the eagle feather can now be used in any feather when speaking from the heart and it has great significance in our culture." He went on to say that sometimes our people are afraid to speak on their own behalf in a courtroom and having an eagle feather present may help him or her. Hector joked that as a very young man he too had once experienced the court-

room from the witness box, " but that was a long long time ago" he said

Rama Elder Lorraine McRae conducted a shortened version of the water ceremony and offered a hand drum song. She spoke to how the water is

in and around us from birth and that praying for the water changes it. She then gently brushed the feathers using the water from the ceremony. The feathers were then presented to Justice Krelove, Justice Nichols and Justice Rosenberg by Hector and Lorraine.

Hector spoke to them about the use of the Eagle Feather in the courts as a significant step for all Ontarians. The Intertribal Peacekeepers Drum Group attended the ceremony and performed an

Shirley Hay, who is Haudenosaunee, and Terri-Dawn Craig who is Ojibway and a member of Rama, began this initiative in 2012. "Our first ceremony was in May 2014 at the Barrie courthouse, the first time ever a ceremony has been held in a courtroom. Shirley was the aboriginal court worker at the Barrie courthouse and I was the Supervisor of Court Operations for the Orillia courthouse when we met. She wanted to have a feather in the courts and once I heard this I had to be involved. Since then we have become best friends." Their goal is to have feathers available in all courts across the province for all First Nations people. They have to date organized 4 cere- Acting Rama Chief of Police and member monies and gifted 5 feathers, in Barrie, Bracebridge, of the Intertribal Police Drum Group, Tom Parry Sound, Orillia and Midland. Terri Craig ex- Batisse plained that the feathers were gifted by the Dene peoples in the North West Territories for the Orillia, Midland and Parry Sound courthouses specifically.

Since 2012, similar initiatives have been undertaken by First Nation's friendship centres and individuals

in Ottawa, Toronto, and North Bay courthouses.

Prayers were offered in Ojibway and by Hector Copegog and Tim Thompson in the Iroquois language. Tim related to the courtroom that there are similarities

but also significant differences between the Haudenosaunee and Ojibway Cultures. He remarked that few outside of First Nations people are aware of this.

The feast consisted of bison, wild rice, 3sisters casserole, berry salad, baked and fried bannock, cedar tea and strawberry tea.

WHAT'S THE RISK?

Smoking fires account for 8% of all home fires

One in 10 smoking fires results in an injury or death.

One in four home fire fatalities are caused by smoking.

65% of smoking fires are caused by "**improper discarding**" of smoking materials.

How do I prevent a smoking fire?

- Encourage smokers to smoke outside.
- Do not extinguish cigarettes in plant pots, which may contain a mixture of peat moss, shredded wood and bark that can easily ignite.

- Use large, deep ashtrays that cannot be knocked over.
- Empty ashes into a metal container not the garbage can – and put it outside.
- If people have been smoking in your home, check behind chair and sofa cushions for cigarette butts before going to bed.



Install smoke alarms on every storey of your home and outside all sleeping areas.



Important changes to Status Registration Program

New forms have been introduced by Indian Affairs for registering for Indian status beginning April 1st, 2018.

Rather than having a separate application for each area (Bill C-31, Bill C-3 or Bill S-3 etc.) Indian Affairs has stream lined the application process and have tried to make it culturally sensitive and person centred.

The new application also has the option for applying for a secure certificate of Indian status (SCIS) at the same time.
