Chief and Council Update for November 2019 Chief Philip Franks

As usual the following are briefs on areas of activities Council has been addressing. Council meets with administration usually weekly to deal with items that are not in the general scope of the Wahta administration and its pre-determined authorities in development or finances, including being signatories to any new funding arrangement documents that may come in. Council receives updates on programs and projects and makes recommendations where needed.

Change to Snow Services: One of those areas discussed was the upcoming snow removal from driveways for community members who are not senior or disabled. After studying the recommendations from staff, it was determined that this service is not feasible to operate. A growing demand of seniors who require snow plow services, and aging equipment, were big factors in Council withdrawing from the snow plow service (except those served by Community Support Services for elderly). Those who need to find a plow contractor should contact the administration office for suggestions.

General Meeting: At the meeting there were four items on the agenda. The new Election Regulations were voted on and accepted. As prescribed in the existing regulations the vote was to be a show of hands at a public meeting called for that purpose. These will be in effect for the 2020 election in March. Changes can be found in the package all members received late in September. If you have any questions please call.

There was a discussion on proposed citizenship codes. The question of lineage vs blood quantum is a big issue on how Wahta Mohawks will continue to exist in the future. More on membership will occur.

The audited financial statements for 2018-2019 as of the end of March were presented by our auditing firm. Once again there were no issues from the auditor with the finances as presented, and Wahta is in a very strong financial position according to Indigenous Services Canada's rating scale of financial health.

The last item was the Wahta Mohawks Community Trust. The quarterly presentation once again touched on how the trust board functions, trust responsibilities, and our investments. There was some discussion on perhaps moving up a level with part of the portfolio to gain better interest returns. The overall trust investment policy is to be conservative investment risk takers so the principal amounts stay protected if a financial market downfall were to occur.

November 11 is coming soon, please remember to attend Remembrance Day Ceremonies at the Wahta Cenotaph outside the Administration building. Each year the site of Remembrance alternates between Wahta Mohawks and the Bala Legion. The alternating tradition has been going on for decades now.

Economic Development Board Council was hoping to meet with board interested members recently after an initial meeting with them to hear a presentation on the by laws and how to work with them. The members had earlier put together suggestions for a set of Board Terms of Reference. These were taken back by our lawyer to be incorporated into the bylaws. To date we have not received the document but expect to soon. There will then be a final bylaw document to be considered to acceptance.

OPP Enforcement Having put the Wahta Trespass By Law into affect this year we still await word from Ontario Provincial Police as to their enforcing the law. Their legal team was to be reviewing our by law which is enacted under the Indian Act. I have heard this is an issue on many First Nations where a FN police force does not exist. Council will be working on hearing an OPP position likely into the winter.

Federal / Provincial Relations: After the October 21st Canadian election and the end result of a minority government, it appears there will be little effect on our relationships with the federal government. The federal

government has lately been working toward creating a new relationship with Indigenous people. Their first major attempt was creating a federal Indigenous Rights Framework. That being said, there is still much work to do. Going forward with a new relationship has to include First Nations people at the table from the start as part of a planning process, unlike with the rights framework that was handed over to us as if it was completed. That is why that framework did not succeed. We will be working with and through our associations to work with all parties that now currently hold power in the federal government.

Meanwhile in Ontario, the Chiefs Council of the Association of Iroquois and Allied Indians have been meeting with some Ministers of Premier Fords government to enlighten them on the issues we face. I have been part of the AIAI Health Social Advisory where priority items included Mental Health and Addictions, Supports for Elders, Disabled, and Chronically III, Water (drinking, and protection of water sources), Human Trafficking and Corrections, and Child Welfare. Recently a booklet was developed outlining each of these problem areas, providing statistics, and offering solutions. The booklet is being used as a guide when meeting with governments.

Land Acknowledgement Process There are currently within Muskoka District, people who have been meeting on how to best development a land acknowledgement that can be used by local governments when opening meetings, or by other groups who may wish to do the same. This meeting is attended by Chiefs or delegates, and mayors or their delegates from Muskoka Towns and Townships. Wahta could not attend the last one however the message coming from Indigenous leaders is a common theme and that is that a land acknowledgement must include all nations that may have been here, and that a land acknowledgement is not just something to be said. It must be heartfelt and an acceptance of our existence long before colonial governments came to these lands. This should be the basis of the beginning of a reconciliation process in this area.

ATR Process The Addition to Reserve process continues. This is a tedious process that is deals with many areas of legal and environmental policies that have to be cleared before Indigenous Services will accept the land back from the province so that it can be returned to reserve status. When we began the process some time ago I was somewhat optimistic we could be done in three years. Indications are now that it could be two more years before we see our land returned. Council wants the process complete so myself along with reps Murray Maracle and Scot Aubichon are doing the best we can to make sure the process keeps moving as quickly as possible. Most of the work lies with the two governments to complete.

Upcoming Council will be dealing with number of issues as we enter the final winter of this term of office. Some of them are clean up issues from as far back as 2012, many are recent issues. Work still has to be done regarding hunting and fishing. Ontario has been slow to comment on what they consider to be their position on our hunting and fishing rights. With the highway 400 land issue we continue to try have the Ministry of Transportation come to our table to work that out. Similar to that, Hydro One has not been back for some time with regard to their five year plans regarding a distribution station, or the provision of three phase power in the community or hearing our developmental plans that will require extra electricity in the future. I am grateful that with many initiatives ongoing that we have a good staff that are working on the administration's projects such as capital assets regarding housing, communications, infrastructure, human services etc. This leaves more time for Council to tend to those issues that involve political leadership to look after our interests as citizens and our rights and lands.

Re: Federal Indian Day School Class Action Settlement Approval

We write to you as Class Counsel to provide important information regarding the Federal Indian Day Schools and Federal Day Schools Class Action.

Settlement Approved for Survivors of Federal Indian Day Schools and Federal Day Schools

On August 19, 2019, the Federal Court approved the Settlement Agreement to compensate survivors for harms suffered while attending Federal Indian Day Schools and Federal Day Schools ("Day Schools"). The settlement includes compensation for eligible Survivor Class Members ranging from \$10,000 to \$200,000 based on the level of harm experienced as well as the creation of a \$200 million Legacy Fund to support commemoration projects, health and wellness projects, and language and culture initiatives.

To receive compensation, a person must be an eligible Class Member. Eligible Class Members are former students of a Federal Indian Day School or Federal Day School during the Claims Period and identified in Schedule K of the Settlement Agreement. Schedule K, enclosed, is also available on the Indian Day School Website provided below or by calling our toll free number: **1 (844) 539-3815**.

Compensation and Claims Process

In order to receive compensation, claimants must complete and submit a Claims Form to the Claims Administrator. Please note that the Claims Form is <u>not the same</u> as the Gowling WLG registration form.

Indian Status Update

Some recent changes have been made to the Indian Act regarding status eligibility.

Did your mother or grandmother or great grandmother lose their Indian status due to marrying a non-native?

Was your mother or grandmother or great grandmother born out of wedlock of a native father and a non-native mother between Sept 4, 1951 and April 16, 1985?

Did your parent or grandparent or great grandparent lose their status because of their mother's marriage to a non-native man before April 17, 1985?

Was your parent or grandparent or great grandparent's name, omitted or deleted from the Indian registry or band list because of their non-native paternity?

If this is the case, you and your children or grandchildren may be eligible for status.

West Nile Virus Monitoring



If you see a device like the one pictured in the woods, don't disturb it. It's a mosquito trap used by the Wahta Mohawks to collect samples as part of its surveillance of West Nile Virus in the community. Traps have been set up in 4 locations, evenly spaced throughout the area. They are mostly off the beaten path in wooded areas. We do move the traps around sometimes. Traps are checked and emptied weekly.

All it takes is one mosquito bite to become infected with West Nile Virus. About one in 150 people infected will develop serious symptoms, such as high fever, headache, neck stiffness, stupor, vision loss, numbness, and paralysis. Symptoms could last several

weeks, and neurological effects could be permanent. Up to 20 percent of people infected will have milder symptoms, and about 80 percent won't have any symptoms at all.

To reduce the risks of infection, the Health Canada advises eliminating mosquito breeding sites by getting rid of standing water, wearing insect repellent, avoiding the outdoors at dawn and in the early evening, and fixing screens to keep mosquitoes out of your house.

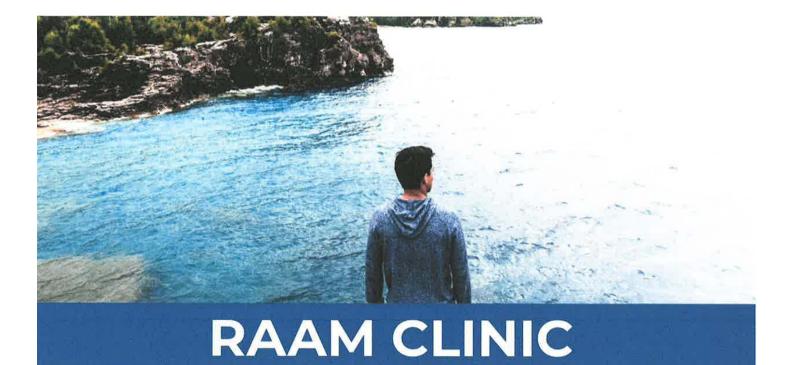

What is the RAAM Clinic?

RAAM is a low-barrier, culturally safe clinic available by Walk-in or Referral. Although not required, referrals are helpful and appreciated. It is for individuals aged <u>16 or older</u>, who are looking for help with their subsance use. The providers (Nurse Practitioner or Physician), have experience treating people who are struggling with their drinking or substance use, and know how difficult it can be to ask for help.

Individuals are welcome to come to the clinic even if there is uncertainty as to whether the addiction is an issue or alternatively if it is a known issue and support is desired.

Services Provided

- Care that is culturally competent
- Assess substance use concerns (includes multisubstance use) and concurrent mental health concerns
- Initiate pharmacotherapy if indicated: Alcohol Use Disorders, Opioid Use Disorders
- Anticraving medication for alcohol
- Suboxone induction and stabilization
- Provide harm reduction interventions and advice
- Provide solution-focused counselling
- Provide trauma-informed care
- Make appropriate links to community partners for addiction, psychosocial and social support services
- Transition clients back to their primary care provider when stable
- Help in connecting clients to a primary care provider if needed

Services Not Provided

- Management of acute/severe withdrawal. Clients in severe withdrawal should call 911 or present to the emergency department
- Management of acute intoxication; for alcohol Client should have their last drink the night before
- Replacement of primary care services
- Long-term psychotherapy
- Management of acute psychiatric illness
- Diagnosis, treatment, or opioid prescriptions for chronic pain
- Safe injection site services
