## **Council Update for December**

## **Chief Philip Franks**

Once again we are approaching the end of another year. As always there are many items on the burner for Council's consideration. The following will highlight some of the issues that Council has been dealing with since the last newsletter.

**Citizenship** There is a community meeting slated for December 7<sup>th</sup>. Council has distributed a draft of a citizenship code and this will be the item for discussion. To assist in presenting will be Jay Herbert. Jay can offer legal insights into why some items may be as prescribed in the revised Code. Other items are truly Wahta member issues, and will help define who is a member going forward. I urge everyone to attend, and also to take a few moments to write or email the office with any comments. Correspondence can be directed to the membership office, <u>karen.sahanatien@wahtamohawks.ca</u>.

**By Law Enforcement** Over the past few years there have been instances where there have been conflicts with trespass, not only general trespassing on Wahta Territory, but in areas of housing and real estate deals gone wrong. To assist with those, council introduced and enacted a by-law to deal with trespassing. This led to the follow up to that and how to enforce First Nation by laws. Our policing system is with the Ontario Provincial Police. Having inquired about OPP enforcing our laws we now understand this is a province wide issue with such enforcement. The OPP are questioning their ability to enforce such laws. I will be attending a meeting with AIAI Chiefs on November 21<sup>st</sup>, and those discussions will be happening to try and get some resolution to the problem. I will be emphasizing the urgency of having some resolution to these complex legal issues.

**Law Making and Cannabis** Council is comparing a number of different First Nation laws that have been created around the issue of growing or selling cannabis. The current laws about being licensed by Ontario and Canada or sellers are illegal and subject to arrest. Council is looking at how the development of a law regarding this would or could be implemented and if it will or can be enforced. This issue will still take some time to go through the process with our membership.

**Housing** Council is awaiting a final go ahead to begin work on the three duplexes that have been in the works for some time now. The inability to secure a general contractor this year and the cost factor has led council to put out tenders for modular home builds. Quotes are in and now we are looking at comparison of the specifications to ensure they meet our needs and requirements of Indigenous Services Canada. This significant capital project will go ahead in the spring given all details are worked out.

Along the same line I recently took part in a housing department meeting with a major bank to look at options for providing housing opportunities to our members. We understand to undertake a new build is a great task and many people do not have the capital to get started through a guaranteed mortgage, and all of the requirements from three levels of authority. One idea that could be explored by the community in the future might be for Wahta to build homes and put them up for sale, or rent to own arrangements. Clearly the systems we have now does not work for everyone.

**Understanding Governance:** I recently stated in this column my interest in finding a way to assist our members in understanding how Wahta governance works, and with the control we have, how we can maintain that based on our rights as Mohawk people. Council operates by policies that have been set forth to ensure accountability and fairness for the membership. Most of the path is directed by things such as the Indian Act. But to truly get an understanding of the big picture I would like to see a more

simplified way of explaining our political history and why we maintain our positions with Ontario and Canada. Having spoken with the deputy Grand Chief of AIAI back in August we agreed it would be beneficial because it is so important. Currently AIAI is assessing and measuring feedback from people on what they need to understand better amidst a quite complicated story. I hope we can begin introducing some better communication around this in the new year.

**Youth Engagement** Youth are the future of First Nations. Through the Association of Iroquois and Allied Indians we have opportunities to fund activities to assist young people to get involved in the issues of these times and to express their voice. Some communities have up and running youth councils who add their voice at community meetings and at Council. I believe this is very worthwhile in sustaining our future and look forward to implementing some of the activities that will help with this.

**Health Transformation:** Council continues to monitor the situation with the creation of Ontario Health Teams and how these changes could effect our health system. Most of the changes will be on how services for primary care, doctors and hospitals operate. Council is working diligently to ensure funding is not affected for seniors. In our area an Ontario Health Team for Muskoka is close to being a reality. Council will be meeting with leaders of that initiative to have our input and concerns put forward. I am hoping we can instil some ongoing affect into the protection of those services.

**General Election:** With Wahta's new election regulations, the process of election for Chief and Council is right around the corner. The process begins in January. Please read the Electoral Officers information in this newsletter, and it is a very different timetable to either run for office or to vote from a distance.

**Projects Ongoing** In partnership with our Administrative staff, the Community Trust, and various funding agencies, Council has approved or help develop a great number of ongoing projects. Good drinking water at the main building and public access to that water, hoping to decide on the best way to put good drinking water into every home next year, repairing and preserving our communities monument, installation of better internet systems at the administration buildings, business development board, the list goes on. It is my hope we will be able to publish a round up of all the projects, plans, and achievements for the membership early in the year.

Strange as it seems to me at this early date, this will be the last newsletter of the year. At this time on behalf of Councillors Commandant, Greasley, Schell, Strength-Fenton and myself I would like to wish everyone a safe and happy Christmas season, and all the best in the coming year.

## October 2019 Community Meeting Minutes

## Wahta Mohawks Community Meeting Minutes Date: Tuesday October 1, 2019

- I. **Present**: Chief Philip Franks, Councillor Blaine Commandant, Councillor Teresa Greasley, Councillor Strength-Fenton. Regrets Councillor Lawrence Schell.
- II. Call to Order: The meeting was called to order at 7:06 pm.
- **III.** Adoption of the Agenda: Moved by Councillor Commandant, Seconded by Councillor Greasley. Carried.
- **IV.** Adoption of Minutes of September 3, 2019: Moved by Councillor Commandant, Seconded by Councillor Strength-Fenton. Carried.

## V. Actions Arising from Minutes:

Guard rails are now installed. The Mayor of Oka apologized for his comments regarding the land issues within Kanesatake.

## VI. New Business:

- Health Budgets Approval Health and Social budgets have been approved. There will be an RN Nurse position hired for secondary health and home care needs. This will include assessments, surgery aftercare, check ups etc. This position is not related to the Health Hub but will be an additional service to community members.
- Ontario Health Team Ontario is dismantling the LHIN (Local Health Integrated Networks). A new body will be set up locally to form Ontario Health Teams, they are required to consult with First Nation communities which to date has not been satisfactory. More work is needed to ensure other funding such as AIAI dollars are not redirected away from the best interests of First Nation communities. A meeting is scheduled to discuss further consultation and how funding will be directed appropriately.
- Kagita Mikam Board Carol Holmes has been approved to join the Board. This Board helps to manage funding for employment and training services.
- **Bala Legion Tent Loan** The Bala Legion has requested a tent rental donation; this has been granted by council. The Bala Legion must provide their own insurance, a waiver will be signed, they must also set it up themselves.
- **AIAI Youth Council** The representative is Brooke Temple. Funding of \$25 000 will be provided to each community to build capacity for youth to be involved in political

areas of concern, training etc.

• ATR – Monthly meetings are taking place for completion of the Additions to Reserve, the process is slow. Environmental assessments need to be redone, Hydro One and Bell permits needed. Permits also need to be drafted for the snowmobile club, Sandy Grey and Roderick Lake permits. Shore road allowances and hunt camp assessments also required. Numerous activities are ongoing, but the process will likely take another 2 years.

## VII. Old Business/ Follow-up:

- Hunting & Fishing A letter was sent to the Province and Federal agencies outlining our concerns about the inconsistent position of the Province. We believe our rights are based on the 1701 treaty area. No fulsome response has been received to date.
- **Development Board Update** The purpose of the Board is to oversee any sustainable income through business activities. A meeting was held with the lawyer last week to discuss the governing documents and how the council will work effectively with the Board. The next step is to set priorities for areas of growth that the Board can start developing.

**09.11 04** – Motion to appoint Carol Holmes to the Kagita Mikam Aboriginal Employment & Training Board of Directors. Carried by consensus.

**09.11.05** – Motion to approve the application to the Wahta Mohawks Trust for repairs to the Chiefs Monument submitted by Senior Administration. Carried by consensus.

**09.11.08** – Motion to approve the disposal of a Silverado Truck that is no longer operational as per the Capital Assets Disposal policy. Carried by consensus.

# Maintenance & Public Works Update

## Landfill Site Christmas Hours

The Landfill site will be closed December 25<sup>th</sup> 2019, and January 1<sup>st</sup>, 2020. There will be regular hours on Saturday December 28<sup>th</sup>, 2019 and Saturday January 4<sup>th</sup>, 2020.

## Solid Waste Study

The Solid Waste Study is continuing. We will be sampling the water from the test wells in early spring and that will wrap up the study. The consultant continuers to assess our options and should have an interim report mid-December. In late November, the Maintenance & Public staff visited Waste Connections Bracebridge facility to learn more about how our recyclables are collected and handled.

## **Community Water Study**

Work continues on the removal of the do not consume order for the Community Center/Administration Office. Once this work is done, the water at the facility will be safe to drink. There will also be a bottle filling station outside the building to provide the community with safe water. So far, the indications are that individual wells and septic systems may be the route the community goes for water supply. We are looking at individual treatment options so the quality of members of water is improved. We drilled two test wells in November as part of the assessment and will have results after Christmas. These wells were drilled in a location that they are available for future use.



## What is the RAAM Clinic?

RAAM is a low-barrier, culturally safe clinic available by Walk-in or Referral. Although not required, referrals are helpful and appreciated. It is for individuals aged <u>16 or older</u>, who are looking for help with their subsance use. The providers (Nurse Practitioner or Physician), have experience treating people who are struggling with their drinking or substance use, and know how difficult it can be to ask for help.

Individuals are welcome to come to the clinic even if there is uncertainty as to whether the addiction is an issue or alternatively if it is a known issue and support is desired.

## **Services Provided**

- Care that is culturally competent
- Assess substance use concerns (includes multisubstance use) and concurrent mental health concerns
- Initiate pharmacotherapy if indicated: Alcohol Use Disorders, Opioid Use Disorders
- Anticraving medication for alcohol
- Suboxone induction and stabilization
- Provide harm reduction interventions and advice
- Provide solution-focused counselling
- Provide trauma-informed care
- Make appropriate links to community partners for addiction, psychosocial and social support services
- Transition clients back to their primary care provider when stable
- Help in connecting clients to a primary care provider if needed

## Services Not Provided

- Management of acute/severe withdrawal. Clients in severe withdrawal should call 911 or present to the emergency department
- Management of acute intoxication; for alcohol Client should have their last drink the night before
- Replacement of primary care services
- Long-term psychotherapy
- Management of acute psychiatric illness
- Diagnosis, treatment, or opioid prescriptions for chronic pain
- Safe injection site services

- Provide a urine sample for drug screening at each clinic visit
- Appointments with medical staff (Nurse Practitioner or Physician), and addictions counsellors
- Detailed history, explore substance use concerns and recovery
- Regularly scheduled clinic visits based on clinical progress

We do not provide emergency medical services, or acute/severe withdrawal detox. If you are in severe withdrawal please visit the emergency department. Please do not present intoxicated. Have your last drink the night before.
